

Education Grant – 2020 Academic Year SHORT COURSES/CERTIFICATE/DIPLOMA STUDY

(This Application form must be used for the above study types completed in the 2021 Academic Year)

The Raukawa Charitable Trust on behalf of the Raukawa Settlement Trust administers the annual Education Grants. The Education Grants are available for Tuition Fees only.

To qualify for all 2020 Education Grants you will need to:

- Be a verified registered member of the Raukawa Settlement Trust,
- who resides in NZ,
- and who completed study at a tertiary education institution or recognised provider in NZ.

This grant is available for fulltime or part-time study.

The Study Types covered with this grant are defined as follows:

- a) Short course/Kura Reo/Te Uru Raukawa
- b) Certificate
- c) Diploma

The tenure of the grant is for one year (the 2020 academic year). Applicants are able to submit a new application each academic year.

This grant is paid retrospectively, that is, that applicants will have already completed the course of study, prior to applying for this grant.

Applicants **must** provide the following supporting documentation along with the application form:

- Official confirmation of enrolment,
- Official study fees invoice from the tertiary institution or recognised provider.
- The verified academic record/results for the study completed during the 2020 year.
- Applicants must have attained a minimum pass mark of 50% for the overall course of study completed in 2019.
- Consecutive years grants will depend on the academic results from the previous year.
- A personal statement is required to support every application. This is to be a minimum of 100 words outlining your current and intended future involvement with their Marae/Iwi. Personal statements will be forwarded to the respective Marae committee for their information.

WHAT HAPPENS IF THE APPLICATION IS...?

Approved: You will be notified in writing. Monies will be paid into your bank account by direct credit.

Declined: You will be notified in writing within two months after the closing date, with reasons why the application has been declined.

Terms and Conditions

- An application for the Education Grant 2020 must be completed for the grant to be paid.
- The Education Grants Sub-committee has delegated authority to accept or decline any application along with the level funding granted.
- All decisions are final and no disputes or correspondence will be entered into regarding any of these decisions.
